- (iv) That the school shall comply with the provisions of section 10(1) read with Rule 125 of DSEAR, 1973.
- (v) That the school shall observe the relevant provisions of RTE Act, 2009 of DSEAR, 1973 and directions/Instructions/Guidelines issued by the Department from time to time.

- (vi) That the school shall comply with the orders/guidelines of DoE and judicial pronouncements w.r.t utilization/maintenance of school funds.
- (vii) That the school will renew the FDR within 01 month in favour of DDE(North) & Manager of the school.
- (viii) That the School Authority will submitted Police Verification in respect of all staff(Teaching and Non Teaching) within 03 months from the issue of letter of extension of provision recognition /up-gradation.
- (ix) That the school shall comply with the order dated 07/11/2017 Guidelines of DOE and judicial pronouncements w.r.t. safety of the students and shall take all necessary steps to this effect.
- (x) That the DDE District shall ensure that the aforesaid terms & Conditions are being complied with by the school Management in letter and spirit.
